Art.1 par. 1 sent. 1 Constitution of FRG

No one may be disadvantaged or specially privileged by virtue of his/her sex, ancestry, race, language, country of origin, faith or religious or political views.

Art. 3 par. 3 sent 1 Constitution of FRG

Marriage and family fall under the special protection of the state.

Art. 6 par. 1 Constitution of FRG

Political refugees are guaranteed the right of asylum.

Art. 16a par. 1 Constitution of FRG

The Legal Aid for Foreigners Munich e.V. is an institution to ensure a social and legal welfare of foreign fellow citizens who are needy, victims of political and/or religious persecution or who are disadvantaged due to their status as foreigners in the FRG.

The Legal Aid for Foreigners appeals to the public to inform of the special social and legal situation of the foreign fellow citizens and the problems that arise from this special situation. Furthermore, the Legal Aid for Foreigners wants to present solutions for a peaceful and friendly living of the German and foreign fellow citizens.

The Legal Aid for Foreigners tries to realize its aims in cooperation with other persons, associations and organizations. The work of the Legal Aid for Foreigners is financed by membership fees, collections, donations and public events.
